**INFORMATION ON THE CUSTOMARY GIFT:**

- The customary gift is exercised independently of a gift.
- A customary gift is a low-value present made on the occasion of a particular event (birth, wedding, Christmas, birthday, examination, others) and must not result in the donor's impoverishment.
- It is generally accepted, from a civil and tax point of view, that a gift of use does not fall within the scope of the donor's estate.
- A customary gift is established without the presence of a civil-law notary.
- If the donor is a protected adult benefiting from a power of representation (guardianship or family habilitation), this document must be signed by the legally designated representative, and accompanied by a specific authorization from the Court for this operation.
- If the donor is a protected adult benefiting from a power of assistance (curatorship or safeguard of justice), this document must be signed by the account holder **and** by his legally designated representative, accompanied by a copy of the Court order concerned by the valid protection measure.

## PROTECTION OF PERSONAL DATA

Personal data will be retained for five (5) full calendar years after the account is closed. The rights of access, rectification, deletion, and portability pertaining to the personal data that you have provided as well as the right to provide instructions regarding your personal data after your death and to request the limitation of the processing of your personal data may be exercised with Shareholder Services:
